What is a WisLine?

A WisLine is a live teleconference offered by the University of Wisconsin-Extension that you attend from your home or office telephone. Presenters who have expert knowledge on the topic will offer an informal talk and an opportunity for questions and answers. Because there is no visual presentation in these teleconferences, it's recommended that you follow along with the supporting materials you will receive.

If you cannot attend the live session, you have the option to purchase the program in one of two formats:

- **Materials Bundle:** a CD recording of the program and a paper copy of the printed materials
- **Audiostream:** streaming audio and PDF of the materials. Includes a digital recording of the broadcast and a digital copy of the reference materials to be sent 2-3 weeks following the program

With the materials bundle and the audiostream, you will be able to hear the question-and-answer session that occurred in the live teleconference, but will not have a chance to ask your own questions.
